Total active, financial members at 30 June 2021 was 1373. This is 93 more than at the same time last year.


Total active members, both financial and unfinancial, at 30 June 2021 was 1418. This is 103 more members than at the same time last year.



# CEO's message

As the world continues to grapple with COVID-19, IPEd continues to reach out to our membership to provide support and assistance to those who need it most. A steady rise in membership numbers during 2020–21

means that now, more than ever, editors are looking to their industry association for support in their career and business.

This has also meant managing ongoing challenges for IPEd to continue delivering key events such as preparations for the 2020 Accreditation Exam and planning considerations for the 2021 IPEd conference.

## Strategic plan 2020-23

The Board reaffirmed IPEd's focus for its 2020–23 strategic priorities is to continue work in the four key areas:

- 1. Build a strong organisation
- 2. Support a thriving membership
- 3. Deliver integrated professional development
- 4. Promote IPEd as the trusted voice of the profession.

As part of the process, the Board met in May this year to refocus our priorities for the 2021–22 cycle.

### **Advocacy**

In 2020–21, we have continued to work with peak bodies to raise issues that affect editors and to support our profession.

#### Pay rates

Our work on pay rates remains a strong focus for the Pay Rates Working Party, which develops benchmark pay scales for Australian and New Zealand editors and promotes their adoption by publishers, government, business and other clients. A new piece of work will examine rates for in-house editors in publishing.

#### The Ambassadors Program

The Ambassadors Program began in 2019 as a two-year pilot program funded by the Copyright Agency Cultural Fund to enhance the editing profession and educate industry about the role of editors in the publishing process. The program has enabled IPEd members to speak to aspiring authors, the public and university students about the role of editors and how they can assist during all stages of the writing and editing process.

Due to the COVID-19 pandemic, the program stalled for a few months, but funding was extended until the end of 2021, while presentations moved to an online format. Eight presentations were given online during 2020-21 to a total of 234 attendees at the following organisations:

Both online and face-to-face presentations will continue for the remainder of 2021. The feedback from participants has continued to be positive and we hope to record both academic and general presentations and to make them available to authors, editors, university students and the public as an ongoing accessible resource.

#### Publisher's indemnity clause

IPEd wrote to the Australian Publishers Association (APA) about an issue raised by some members in relation to contracts between publishers and editors, in particular to a publisher's indemnity clause, which shifts unreasonable responsibility onto editors. IPEd stated that we believe that position to be unfair and unwarranted and asked APA to work with their members and those outside their membership to resolve this issue.

# Partnerships and affiliates Partnerships

IPEd continues our partnership with Biotext–Macquarie to promote the Australian Manual of Style (AMOS) and Style Hub.

IPEd welcomed a new partnership with the Brisbane Writers Festival (BWF) to develop 10 episodes showcasing the relationship between author and editor in the publishing process.

At the BWF in May, an author-editor panel chaired by Ashley Hay featuring Grace Lucas-Pennington, Anne-Marie Te Whiu and Catherine Milne was programmed. However, Catherine Milne was unable to travel due to border restrictions. The panel discussion was well received, with the chair and participants receiving positive feedback.

#### **Affiliates**

IPEd wrote to more than a dozen like-minded associations and organisations to develop affiliate relationships. That work is continuing. We look forward to providing a list of affiliates on our website in the coming year and to providing further connections for members to enjoy affiliate events, professional development and resources.

#### Resources

A contract template between IPEd and the Australian Society of Authors was released to joint members. The template is available to our respective memberships for free as part of a growing suite of services we hope to offer in future.

### **Activities**

#### **Editors Directory**

There are currently 409 active Editors Directory subscriptions. (A breakdown of branch figures for 2021 and a graph showing the growth in total subscriptions from 2019 are on page 13.)

#### Conference

Editors Tasmania, led by Conference Convenor and Branch President Elizabeth Spiegel AE, presented IPEd's 10th Editors Conference, Editing on the edges, from 28 to 30 June 2021. The conference committee faced some of the most challenging event conditions that any committee has ever encountered, necessitating a shift from a much-anticipated inperson conference to IPEd's first completely online conference using Zoom. Thanks to the committee's hard work and members' support for the new format, the conference was attended by 278 delegates from

around Australia, Aotearoa New Zealand, South Africa, the United States of America, the United Kingdom and Europe.

A conference report will be available later but early indications from formal and informal feedback are that the conference was a success. More than 90 per cent of respondents stated that the registration fee was acceptable or cheap, and 96 per cent said the registration process was smooth or acceptable. Of those who answered questions about quality of the speakers and application to their professional practice, 72 per cent rated the speakers as excellent or good, and 80 per cent indicated the application to their work practice was excellent or good.

Feedback was strong about improved and deepened awareness of diversity, accessibility and inclusion in editing, increased professional confidence and practical strategies and methods for improving business activities like marketing, planning and communicating with clients.

These results bode well for Editors Aotearoa New Zealand, who are due to host IPEd's first international conference in Wellington in 2023.

#### Accreditation exam

The IPEd accreditation exam on 5 December 2020 went smoothly, overall. A total of 99 candidates sat the exam, 94 in one of seven venues (Adelaide, Brisbane, Canberra, Melbourne, Perth, Sydney and Wellington) plus five remote candidates. All registered candidates turned up and stayed until the exam ended. Fifty-eight of the 99 candidates who sat the exam achieved at least 80 per cent (the overall minimum pass mark needed to demonstrate their editing competence).





# Chair's report

While the word of the year for 2020
— as judged by many dictionaries,
websites and societies — was some
variation on 'pandemic', the word
for 2021 surely will be on the theme
of 'resilience', probably in the form of
something more specific, like 'vaccine'.

It's been a full year of lockdown cycles, plans changing and expectations being continuously adjusted. Yet through this we've managed to deliver two excellent flagship events: the accreditation exam and the conference. Branches have also been busier than ever delivering workshops and speaker presentations. Most branches are staying with Zoom for their meetings. Despite the downside of missing the shared experience of being in a room together, we've found enormous benefit in the increased accessibility for regional members and members from other branches, who can now attend workshops and presentations across Australia and Aotearoa New Zealand.

After a long period with some vacancies on the Board, by the end of 2020 we had the full complement of 10 Directors. We welcomed Catherine Macdonald AE as the Editors Western Australia Director in August and said goodbye to previous Chair Kerry Davies AE, who had remained on the Board since May as a Board-appointed Director. Editors Aotearoa New Zealand Director Anne-Marie McDonald left in July and was replaced by Kimberley Davis in September, when we also welcomed Peter Griffin as our Membership Director. In October, Tania Goodacre joined us as Conference Director.

In November we said farewell to Loene Doube AE for Editors South Australia and welcomed Melanie Dankel AE. Loene had been on the Board since 2016 and had served on the Council from 2014. We said goodbye to Renée Otmar DE

from Editors Victoria and welcomed Lan Wang. Renée had served on the IPEd Council in 2017–18 and filled a vacancy on the Board in 2020. We welcomed Gordon Campbell AE as branch-appointed Director for Editors Tasmania.

In December 2020, 99 people sat the eighth accreditation exam. The Accreditation Board delivered an excellent exam under trying conditions, providing contingency arrangements in case of lockdown for people to be able to sit the exam remotely. That work will also benefit future exams, as we now can improve accessibility of the exam to regional and remote members.

As for so many other organisations around the world in the last year, we had to decide whether we were going to run our conference as a face-to-face event or online or in some hybrid configuration. We surveyed the membership twice to assess how comfortable people felt to travel, and we undertook extensive research and risk analysis. In November, we decided to move to a virtual conference. In the closing days of June 2021, we ran a very successful conference using the Zoom platform.

It was a year for style manuals, with four having been released. IPEd put together a review team — one of four invited by the DTA — for the Australian Government Style manual and conducted a preliminary review of Biotext–Macquarie's Australian manual of style (AMOS) for its possible use in the accreditation exam.

IPEd is strengthening its ties with industry partners. With the Brisbane Writers Festival, we ran a series of 10 author—editor interviews that are available until the end of 2021. We set up our new arrangement with Biotext—Macquarie where members can subscribe to AMOS through IPEd to receive a discount and IPEd receives part of the sale. And we are formalising arrangements with sister organisations such as CIEP in the UK, PEG in South Africa and Editors Canada.

Two of our working parties became standing committees this year to reflect the ongoing importance of their work: the Communications Standing Committee and the Standing Committee on Australian and Aotearoa New Zealand Style. The Accessibility Initiative Working Party began its work looking at print disability in book and document publishing. And a new group, the IPEd Standards Working Party, was formed to manage the update of the Australian standards for editing practice.

Membership has increased across the year, from 1325 to 1418, and we are now back at the level before transition to a direct membership model.

Two branches had milestone birthdays in October this year: Editors Queensland turned 30 and Editors Victoria turned 50. This longevity is testament to the need for and value of IPEd to editors.

Following on from the strong financial position we achieved last year, this year we consolidated that gain, with a surplus of \$111,566. The Board has approved reinvestment of a good part of these funds into staff for the coming year, so we can further improve member services and acknowledge the commitment of staff.


In the coming year we will focus on implementing the second year of our strategic plan. A key area will be to consider a diversity and inclusion strategy to improve access for and engagement with Aboriginal and Torres Strait Islander and Māori editors, people of colour and people with disabilities. This year we developed an acknowledgement of country for use at all IPEd meetings and across our materials.

I would like to thank the dedicated IPEd Board, staff and contractors, branch committees, standing committees and working parties. All these people work and volunteer to support our members and advance the profession of editing.

# Governance and management

### **Board**

IPEd is governed by a Board of 10 directors comprising one director appointed by each branch and additional directors appointed by the Board, usually for specialist skills.

Branch-appointed directors serve two-year terms, whereas directors appointed by the Board serve terms of up to two years. Directors appointed by Branches may only serve a maximum of three consecutive terms, while Board-appointed Directors can be reappointed to serve further terms at the Board's discretion. The role of the Board is to manage the business and affairs of IPEd, in accordance with the IPEd Constitution and the Corporations Act 2001 of the Commonwealth.

Linda Nix AE, Accreditation Board Chair, continued to attend Board meetings in a non-voting capacity.

#### **Annual General Meeting**

IPEd's Annual General Meeting (AGM) was held on 2 November 2020 via Zoom with 60 members and staff in attendance, and IPEd patron Roly Sussex and auditor Vishal Modi.

Members voted to accept the minutes of the 2019 AGM, confirm director appointments, accept the auditor's report and audited financial statements, and the annual report. A total of 38 votes were received online (via SurveyMonkey), by email or by proxy, with nine members voting at the meeting, for a total of 47 votes. All were confirmed by the tellers as eligible voting members.

Members also voted on three special resolutions to amend the IPEd Constitution. These were:

- Clarification of terms and interpretation –
   93 per cent of votes in favour, declared passed.
- Requirements for the appointment and terms of directors – 84 per cent of votes in favour, declared passed.
- Better corporate governance 83 per cent of votes in favour, declared passed.

The AGM was followed by a member plenary session facilitated by Adrian Hart from Associations Forum. Many thanks to all who attended or participated in the AGM.

## Finance and risk management

The Finance and Risk Management (FRM) Committee assists the IPEd Board to fulfil its corporate governance and statutory responsibilities about financial reporting, internal control, risk management and audit functions.

FRM members at 30 June 2021 were Board Chair Ruth Davies AE, Finance Director Nick Pilavidis, Finance Officer Erin Rundle, Director and Company Secretary Russell Noakes and CEO Karen Lee. Kerry Davies AE, immediate past Chair of IPEd, remained on FRM until the end of her term as a Board-appointed Director in August.

The full-year interim results show a strong surplus achieved through a highly successful virtual conference,

strong growth in membership, branch professional development (PD) and meetings, and the accreditation exam, along with a strong control over expenses.

Overall, income and expenditure from branch events (meetings and PD) produced surpluses totalling \$32,850. Other sources of income were membership fees \$213,753, Editors Directory fees \$20,935, joining fees \$7406, accreditation exam \$74,805 and IPEd PD \$3080.

A total of \$1552 was received as royalties for Janet Mackenzie's title *The Editor's Companion*, bequeathed to IPEd by Janet and \$1843 in donations from IPEd members, which IPEd has decided to direct to future educational activities and promotion.

#### Financial statements

The audit of financial statements for the year ended 30 June 2021 is completed. The final audited statements will be presented at the AGM on 8 November 2021 and can be viewed <u>here</u>.

#### Operating statement

Income for the year was \$534,583. This came from membership fees, the accreditation exam, the conference and branch events. We received \$54,000 in JobKeeper payments, which offset staff salaries, and a \$11,968 cash-flow boost that offset our first quarter Business Activity Statement liability.

Total expenditure for the year was \$423,202. Most expenses were significantly under budget, other than

items where income more than offset the increasein expenses. The Board approved an increase in staff expenses in response to the increase in activity and to reduce external expenditure for the conference. IPEd ended the year with a surplus of \$111,566 (2020 \$47,969).

Honoraria of \$6112 was paid to Board members and Chair. The Accreditation Board and IPEd Board approved an honorarium of \$4500 to the Accreditation Board Chair.

### Balance sheet

The bank balance at 30 June 2021 was \$471,340 (2020 \$332,663). At that date IPEd had receivables of \$412 (2020 \$0.00). Total IPEd assets were \$486,879 (2020 \$349,879).

At 30 June 2021, IPEd had liabilities of \$225,874 (2020 \$200,440), including deferred income of \$165,469 (2020

\$164,106). At 30 June 2021, members' equity totalled \$261,005 (2020 \$149,439). That comprised current year earnings of \$111,566, \$112,786 in branch reserves, \$10,207 in Janet Mackenzie reserved funds and \$26,446 in retained earnings.

## Budget for FY 2020-21

The 2021–22 budget was approved by the Board at its meeting on 19 July 2020. The Board has undertaken a significant strategic budgeting process developing a budget that allows IPEd to further grow its ability to serve its members. Specifically, the resourcing capacity of IPEd staff has been increased in line with the Board's strategic plan. The budget reinvests a portion of the 2020–21 surplus and anticipates a deficit of \$57,955.

When viewed over two years, 2020–21 and 2021–22, a net surplus is achieved and the Board is confident the investment in staffing will enable IPEd to return to a surplus in 2022–23.

During the 2020–21 year, IPEd's volunteer workers were covered by its association liability, voluntary workers personal accident and public liability insurance policies.

### **Communications**

#### **Gatherings**

IPEd has continued to release its monthly IPEd-wide newsletter, *Gatherings*, which was launched in April 2020. *Gatherings* has continued to develop since its inception and has become a valuable resource for members, containing news, events, branch reports and more in every issue.

The Communications Officer (CO) manages production of *Gatherings* by issuing a monthly call for content, collating and copyediting articles, liaising with the volunteer proofreaders, uploading content to the website and email template and distributing the newsletter to all members.

The CO, along with the Communication Standing Committee (CSC), developed a media kit and booking form for advertisements to be included in the email and web versions of *Gatherings*, thus generating an income for IPEd.

#### Conference promotion

The CO has used IPEd's social media platforms and media contacts to promote the 2021 IPEd editing conference, Editing on the edges.

The CO assisted the Conference Convenor by editing acceptance speech videos of the winners of IPEd awards and helping to prepare the opening and closing ceremony videos.

The CO interviewed several presenters in advance of the conference and issued a series of media releases to promote the event.

#### Website

Much of the year was spent on development of a new website for IPEd.

The CO regularly uploads news posts, issues of Gatherings, updates branch page information and more to the website. Website statistics from 1 July 2020 to 30 June 2021: Top performing pages included the home page at 23,013 views, followed by the Find an editor page at 9049 and the Editing courses page at 7841.

Most website visitors are based in Australia, followed by the United States and New Zealand.

#### Social media

IPEd used its social media presence as a resource for communicating with members and non-members and to share posts of interest.

Social media statistics:

At 1 July 2020, Facebook followers were 1166 and by 30 June 2021 they had risen to 1261.

IPEd's Twitter page welcomed 85 new followers between 1 July 2020 to 30 June 2021, taking the total to 1536.

Across the same time, IPEd's LinkedIn page grew by 183 followers, taking the total to 961.

#### Media releases

IPEd regularly distributes media releases to mainstream and specialist publications to spread information about IPEd's projects and achievements. The CO has been gradually building the database to extend our reach across additional media outlets.

Between 1 July 2020 to 30 June 2021, 11 media releases were distributed to IPEd's media contacts.

#### Job alerts, member updates

In support of members, the CO regularly distributes updates, job alerts, surveys and special event notices to keep members informed of potential opportunities to further their professional development.

# Activities for the year

### **Accreditation Board**

Accreditation Board (AB) members are volunteer delegates appointed by each IPEd branch, and on occasion special members recruited for their expertise.

Each member must be an Accredited Editor (AE) or Distinguished Editor (DE). In 2020–21, AB delegate members were:

Ted Briggs AE is a special member and our liaison with the Canberra Society of Editors (CSE).

The report below outlines the AB's main activities in the past year, but does not cover everything we do (not enough space to mention everyone involved). We acknowledge and sincerely thank each of the many volunteers and staff who support our work.

#### 2020 and 2022 accreditation exams

IPEd welcomed 58 new AEs who sat and passed the accreditation exam on Saturday 5 December 2020. The final exam report, submitted to the IPEd Board in April 2021, noted the 'massive amounts of extra work' for the AB and the exam team in delivering several firsts:

- a standardised exam preparation workshop syllabus
- pioneering of online Zoom workshops for IPEd
- platform-neutral exam documents
- an option to sit the exam remotely for those unable to attend one of the seven exam venues in Australia and Aotearoa New Zealand.

These initiatives have contributed to meeting one of IPEd's strategic objectives: to make the accreditation scheme more accessible.

Planning is in progress for the next accreditation exam, which will be on Monday 22 August 2022.

#### Accreditation renewal

The AB instituted a policy change that now requires all AEs to be IPEd members to be eligible for renewal. The change is being phased in as each AE cohort's renewal becomes due. The first cohorts renewing under the new policy are those first accredited in 2011, who renewed in 2016, and those first accredited in 2016. At the time of writing, the application period was still open.

#### Research and policy work

While rolling out its remote exam solution in the second half of 2020, the AB investigated ways to bring the accreditation exam fully online. The lessons gained from the trial of remote delivery alongside venue-based delivery (the 'hybrid model') were incorporated into the AB's broader research into online exams, which included in-depth discussions with potential exam hosting providers.

The result was a detailed feasibility study presented to the IPEd Board in January 2021, a summary of which was published on the IPEd website in March 2021. A particularly surprising finding of the study: not as much support for an online exam as had been assumed. The study concluded that the 'hybrid model' be used for the next exam, and that plans 'for a fully online exam be shelved until there are sufficient benefits and demand to justify the operational costs and capital outlay'.

The AB also spent considerable time in research and consulting the archives on the development of the accreditation scheme from its origins to its current state. As a team, we prepared and presented our findings at the 2021 IPEd conference on 29 June (the full paper will also be published and distributed to members). Key points from the research include:

- The accreditation scheme, as approved by member vote in 2007, was originally conceived as a two-tier scheme comprising a three-hour exam to assess editing competence, and a portfolio assessment of advanced, and possibly specialist, editing skills.
   Editors who passed the exam would be eligible, after a year, to apply for advanced accreditation.
- The first stage, the competence exam, was implemented in 2008. A total of 474 candidates have achieved accreditation as an AE.

- Although the exam has evolved in format and content to meet changes in editing practice, candidate and administrator needs, and IPEd membership notably the inclusion of Aotearoa New Zealand editors and content it still assesses copy editing skills and knowledge against the Australian standards for editing practice.
- Candidate performances in the exam continue to show the need for more training in basic editing competencies, especially practical editing skills.
- The second stage, advanced accreditation by portfolio assessment, has been repeatedly shelved as having too many implementation issues.

#### Focus for 2021-22

The main focus will be the 2022 exam, which at the time of writing is only a year away, but we also plan to re-open investigation into advanced accreditation.

## **Ambassadors Program**

The Ambassadors Program began in 2019 as a twoyear pilot program funded by the Copyright Agency Cultural Fund to enhance the editing profession and educate industry about the role of editors in the publishing process.

The program has enabled IPEd members to speak to aspiring authors, the public and university students about the role of editors and how they can assist during all stages of the writing and editing process.

Due to the COVID-19 pandemic the program stalled for a few months but funding was extended until the end of 2021, while presentations moved to an online format. Eight presentations were given online during 2020-21 to a total of 234 attendees at the following organisations:

Both online and face-to-face presentations will continue for the remainder of 2021. The feedback from participants has continued to be positive and we hope to record both academic and general presentations and make them available to authors, editors, university students and the public as an ongoing accessible resource.

AIVVP was formed in October 2020 to meet the needs of readers with print disability. "Print disability" is a term used to describe any visual, perceptual or physical condition that creates an inability to read, or a difficulty in reading, standard print materials.

AIWP's objectives are to research and create strategies for editors that ensure readers can perceive and understand published materials, irrespective of the sense — vision, hearing or touch — they use to read them. This means learning to think about not just how content looks, but how it sounds and feels when offered in audio and tactile form.

AIWP started by collecting and reviewing many of the available resources on accessibility and identifying gaps for editors and writers, such as how to create image descriptions for children's picture books. The next stage is to research in more depth the barriers faced by readers with print disability. To do this we have been working with the University of Sydney to develop separate surveys of adult and child readers, with support from Round Table on Information Access for People with Print Disability. The surveys will be circulated, and we look forward to analysing the results later in 2021.

The guidelines we develop will also aim to lighten the load for disability support organisations by ensuring content requires as little remediation as possible when published in alternative formats such as braille. A preliminary revelation from Round Table has been that simply changing our standard style from single to double quote marks would save a huge amount of time for braille transcribers.

While closing single quotes are visually indistinguishable from apostrophes, the two have different braille codes. The proofs created by braille-transcription software must be manually checked and corrected for these marks, which is very time-consuming and labour-intensive work. It takes up precious resources that could be better spent elsewhere, so just this one small style change would make a significant difference for their hardworking staff and volunteers.

We hope to begin working with Round Table more closely in the coming months to uncover further information about the issues faced by alternative format providers and their readers, and what editors can do to help avoid them.

IPEd's Communication Working Party was formed to assist with transition activities, specifically the move to a single IPEd newsletter and website. With these tasks nearing completion, in August 2020 the Communication Working Party became the Communication Standing Committee.

CSC's role is to provide advice on improving promotion of IPEd, streamline communication between branches and with members, support the IPEd Communication Officer to deliver IPEd's strategic communication objective, and as requested by the Board or CEO to provide communication advice on sponsorship and events.

CSC has focused on several projects throughout the year including finalising the development of branch logos, which was carried over from the previous year. This project provided each branch with a consistent logo, vital for IPEd's position as a single professional

body representing editors across Australia and Aotearoa New Zealand.

Similarly, the transition to a single website is an important part of IPEd's transition process. In preparation for the closure of branch websites, content was reviewed and assessed for archiving or transition to the IPEd website. Branch newsletters were filed with Trove and/or the National eDeposit Scheme — a significant body of work as every page and item on the branch sites needed to be reviewed and decided on.

In 2021, CSC will be involved in the review of the IPEd website to reflect the professional image of the organisation and its membership.

A major CSC project was to review the IPEd social media policies. These were combined into one document and updated to reflect the changing environment of social media. The policy was submitted to the Board in January.

CSC members also developed an advertising policy for IPEd's *Gatherings* newsletter as a source of income. This project included reviewing advertising rates and specs of similar organisations to determine a sliding scale for *Gatherings*. The rates were adopted by the Finance and Risk Management Committee.

During 2021, CSC members have reviewed the IPEd internal style guide. The review included crosschecking against Australian style manuals and dictionaries, and the Maori Language Commission. Consultation around the draft guide will happen in the second half of 2021.

Throughout the year, CSC members proofread *Gatherings*.

## Mentoring Program

The IPEd Mentoring Program helps participants, both mentees and mentors, improve their knowledge and skills with professional advice and feedback from experienced editors.

The program brings benefits to the editing profession by increasing members' skills. This, in turn, helps safeguard the reputation of the profession as a whole. The Mentoring Program is for editors at all levels, for example:

- · editors entering the profession
- · editors preparing for accreditation
- · people returning to the profession after time off
- editors with any level of experience who want to brush up their skills or move into a new area of editing.

Workshops are run regularly for anyone interested, particularly prospective mentors and mentees, to familiarise participants with the general concepts governing our program. Training is provided for mentors to help them understand the processes involved in a mentorship. In 2020–21 three workshops were held in June and July 2021. Attendance at all workshops was excellent.

At the start of 2020–21 seven mentorships were in place. During the year, five new mentorships were started and seven ended. On average, seven mentorships were in place at any one time during the year.

The Mentoring Standing Committee oversees development and administration of the program. The committee consists of area mentoring coordinators representing all IPEd branches in Australia and

Aotearoa New Zealand, and the Canberra Society of Editors and is jointly chaired by Ted Briggs AE and Elizabeth Manning Murphy DE. Area coordinators were:

A review of the mentoring program took place in the latter half of 2020. Following publication of the 'Fair pay rates for self-employed editors' on the IPEd website in June 2020, the PRWP designed the IPEd member survey, released in March 2021. The survey focused on editors' work and income for the 2019–20 financial year for both self-employed editors and employee editors. The response rate was 36 per cent from eligible members. A report will be released to members in the second half of 2021.

The 'Fair pay rates' information provides a range of rates required to sustain a long-term, viable business. It is particularly useful as a reference for editors and clients when negotiating editing work. The hourly rates and supporting information are presented on the public website, here, in the 'About editing' section, for use by editors (members and non-members) and prospective clients. Additional information and resources for members are on the members-only section, titled 'Pay rates, self-employed editors' under 'Resources for editors'.

In May 2021 the PRWP sent out a request for expressions of interest from members to join the working party to continue its next stage of work to establish similar fair pay rates for EdANZ members and to begin research on improving in-house salaries and working conditions in Australia and Aotearoa New Zealand, and freelance rates offered by publishing houses. We were thrilled to welcome three new members in June (as listed above), though no one yet from EdANZ, and sorry to see Mark Letchford step down in May. The PRWP is also researching ATO and ABS data on editing occupations.

In 2020–22, we will use the results from our survey to continue our advocacy and continue to promote fair pay rates to members and potential clients, including publishing houses, independent authors, universities, and corporate, education and government sectors.

The committee had eight meetings from July 2020 to June 2021.

Much of the committee's work in the latter half of 2020 was to coordinate the IPEd review of the DTA's Style Manual. Three individual applicants (Ted Briggs AE, Ilona Wallace AE and Vicki Snowdon AE) for the review process combined to act as a review team.

They submitted their report to IPEd on 14 August 2020. Some broad themes of the review were that it was well suited to government editors working with web content, had a good focus on user needs, was accessible across different devices, had a clean layout and had good examples and references. Some gaps were that it did not satisfy the needs of trade publishing editors, needed more information on accessibility and needed better search and navigation. Julie Ganner AE and Ted Briggs AE wrote a summary of the review for the November 2020 issue of *Gatherings*.

Once the Style Manual review was submitted, the then-steering group turned to redefining its purpose. The next major discussion was to develop terms of reference for the group, which was ratified in June 2021. Part of this process was renaming the group as the Standing Committee on Australian and Aotearoa New Zealand Style (SCAANZS). This reflects the committee's broader focus on style issues beyond the DTA's Style Manual and its aim to represent IPEd as an organisation for all editors in Aotearoa New Zealand and Australia.

The main activities for the committee are now to:

- confirm committee membership
- support other IPEd committees, such as the Accreditation Board and Communications Standing Committee as they consider matters of style
- support member groups to develop a style guide for editors working in trade publishing
- deliver information to IPEd members through Gatherings, forums and Macquarie StyleHub articles.

# Standing Committee on Academic Editing

The Standing Committee on Academic Editing (SCAE) first met in November 2017 and membership has changed over time.

The terms of reference were reviewed and simplified in late 2020.

#### Activities in 2020–21

- We wrote an article on the federal government's
  Tertiary Education Quality and Standards Agency
  Amendment (Prohibiting Academic Cheating
  Services) Bill 2019, which formally became law in
  September 2020, for Gatherings October 2020.
  Based on the examples provided in the explanatory
  memorandum, editing and providing advice to
  students are not offences under the legislation.
- We developed and released a set of resources for academic editors, for the members-only section of the IPEd website. The resources include a two-page sample agreement for thesis editing in a Word file, which can be modified by editors. Other resources cover common issues in quoting and agreements, plagiarism, verb tense and editing reference lists. The resources were promoted in *Gatherings* in March 2021.
- We developed and released indicative costs for editing a range of academic work as guidance for potential clients in June 2021. The costs are on the IPEd website and were communicated to members

in *Gatherings* in July 2021. SCAE member Rhonda Daniels AE is also a member of IPEd's Pay Rates Working Party, which developed the fair hourly rates for self-employed editors, released in June 2020.

- We initiated work on academic editing in Aotearoa New Zealand, with a review of guidance on thesis editing in New Zealand universities by new member Phil Pope.
- Rhonda Daniels AE and Phil Pope presented at the IPEd editors conference on 30 June 2021 in the session on Navigating academic editing in a COVID-19 world. Rhonda gave an update on the work of the committee and highlighted possible editing business responses to the COVID-19 world. Phil shared his experience of changing career focus due to COVID-19 to become an academic editor and the importance of focused marketing.

#### Plans for 2021–22

The university sector, a major source of work for academic editors, continues to face change and uncertainty from both COVID-19-related impacts and government changes to fees. Impacts are variable across universities, disciplines and teaching and research, and the long tail of COVID-19 is uncertain. With research and its dissemination more important than ever, there are opportunities for academic editors.

We will continue to:

- develop resources for academic editors
- highlight the skills of academic editors and the value of academic editing
- raise awareness of IPEd, the Australian standards for editing practice and IPEd's Guidelines for editing research theses among universities, editors and clients in Aotearoa New Zealand.

## Standing Committee on Awards and Prizes

To raise the profile of editing and editors, and recognise excellence in the field, IPEd supports several awards and prizes through its Standing Committee on Awards and Prizes (SCAP).

#### Rosie winner

The Rosanne Fitzgibbon Editorial Award, known as the Rosie, is awarded every second year and recognises excellence in editing, as demonstrated in one published work.

Johannes Jakob was announced the winner of the 2021 Rosie award for his work on debut writer Kyle Perry's novel *The Bluffs*.

Johannes' work helped transform a raw manuscript into a commercially successful work of crime fiction for Penguin Random House.

The award honours Rosanne Fitzgibbon, a founding member of the then Society of Editors (Queensland), in 1990. Rosie, as she was known, was also a Distinguished Editor and winner of the inaugural Beatrice Davis Fellowship, in 1992.

#### 2021 Janet Mackenzie Medal winner

IPEd's Janet Mackenzie Medal — also known as the Mackenzie — is a service award given to an outstanding professional editor who has lifted the standard of the editing profession and/or given exemplary service to IPEd. IPEd was proud to announce the winner of the 2021 Janet Mackenzie Medal, Edwin (Ted) Briggs AE.

The Mackenzie is IPEd's highest award and honours Janet Mackenzie DE (1947–2018). Janet was an Honorary Life Member (HLM) and founding member of Editors Victoria and served IPEd in many capacities over many years.

Ted made significant contributions to the development of Australian standards for editing practice and played a key role in developing what is now the IPEd Mentoring Program.

Ted, who knew Janet Mackenzie personally, said she had taught him that the editor's role was like a prism in a telescope – it was not to change the view but to bring it into focus more clearly and closer.

#### **IPEd Student Prize**

As part of its objective to support and foster research in editing and publishing, IPEd sponsors an annual prize of \$250 for a student project written as part of the requirements for a degree in editing, publishing or another discipline with a focus on editing.

This year, Greta Lukavic, a student at the University of Melbourne, won the 2021 IPEd Student Prize with her essay, 'Analysing the legal and ethical issues arising from Margaret B Jones's Love and Consequences: A Memoir of Hope and Survival and localising the ramifications of publication'.

# Standing Committee for Professional Development

Like many involved in learning and teaching around the world, the past year has forced the SCPD to reflect and adapt — although not necessarily in that order.

With the pace of change forced upon branch coordinators in 2020–21, the SCPD has largely played the role of information hub this year. Much time has been spent in meetings sharing and discussing ideas and learnings, many of which are now being developed into resources to support branch volunteers (such as protocols for Zoom sessions and COVID-19-safe events). More recently, as our focus has increasingly shifted from adapting to reflecting, we have also drawn on these learnings to identify new priorities for action in the coming year.

First, it has become clear that online professional development is here to stay. As someone with a background in delivering online education and continuing professional development, I have always believed in the value and importance of such opportunities for our members.

Even without the interference of restrictions and lockdowns, online learning opportunities are essential to serving our members' diverse professional development needs, from remote access and flexible scheduling to catering for editors with disabilities. However, while it has been exciting to see the increase in opportunities already afforded to our members by the move online, it has also underscored the need for greater collaboration and consistency.

Second, the injustices of our social and cultural institutions are more visible than ever, and are only going to be exacerbated by the effects of the

pandemic. Thankfully, movements fighting these injustices are also gaining traction, and we, as editors, do not and should not stand apart from them. As professionals responsible for how social issues and marginalised groups are represented in our written language, we firmly believe our members have a vital role to play in progressing the conversation — and we, as IPEd, have an equally vital role to play in empowering our members to do so.

The SCPD has already started to act on these reflections, drawing on our learnings over the past year and our emerging understanding of these new priorities to draft a refreshed IPEd Professional Development Policy in consultation with a range of stakeholders. This policy forms the foundation of an important work program for the coming year, including:

- articulating an approach to diversity and inclusion in professional development at IPEd
- producing guidelines and resources to support volunteers in delivering professional development across IPEd
- creating online learning opportunities that offer both foundational editing skills and major issues in editing practice.

To help us achieve these ambitions in 2021–22, we have recently appointed Dr Sara Kitaoji AE as Co-Chair of the SCPD. I warmly welcome her experience and support as we work towards these goals together with all the members of the SCPD and IPEd more broadly.


# Branch reports

Editors Aotearoa New Zealand
(EdANZ) has had a full and busy year.
The branch committee has strived to
provide our members with value for their
membership and the necessary professional
development to advance their knowledge.

Our hard-working events group is responsible for running the speaker events and professional development opportunities. During this past year, in-person lunches and catch-ups for editors have been offered in Auckland, Wellington, Canterbury and Dunedin.

Earlier this year we revisited our popular themed Zoom hui (meeting) week. We have benefited from an excellent speaker event on Plain English, and workshops on editing Māori language in an English language context, inclusivity, grammar and punctuation. Our panel event on working with trade publishers was extremely well received. And let's not forget the Zoom Christmas party, where Claire Davis ran a quiz for us, complete with prizes.

For the first time, we offered the accreditation exam in Aotearoa New Zealand. On 5 December 2020, six editors sat the exam, with a dinner afterwards for relaxing and socialising. The organisation of this exam was quite an undertaking, and we are grateful to the Accreditation Board for their

support, but particularly to Helen Bradford AE for being the person who made it happen.

This year a contingent of EdANZ members also attended the online conference in June 2021. By setting up a group on the Messenger app, we could share our experiences as they happened and talk about ideas that had made an impression. At the end of the conference, we launched the next IPEd conference, to be held in Wellington in 2023.

At our Annual Branch Meeting in late 2020, we appointed Kimberley Davis as the IPEd Director from Aotearoa New Zealand. Her experience has allowed her to bring much-needed knowledge about New Zealand's industry to the Board, and she was pleased to accept the role of Deputy Chair.

The committee has devoted considerable time to developing a branch strategy to provide future committees with a clear path and set of priorities for the next few years. This process started with personally contacting every branch

member to canvass their opinions on how their expectations of membership were being met, and what they thought was important for the editing profession in New Zealand. We very much believe we are here to serve our members and have enjoyed the strategising to help define what we need to focus on.

As we approach the latter part of the year and our ABM, some of our committee members, all of whom have worked hard over the past two years, will stand down to allow others to step up and experience the professional development and satisfaction of serving the editors of Aotearoa New Zealand. My thanks to all our committee members for another wonderful year working together and sharing the bumps of committee life. To those who are staying, I look forward to working with you over the next year, advocating for editing and editors.







other events, on Zoom and was followed by a

This year efforts were made to reignite our networking and face-to-face catch-ups (COVID-19 permitting) with events such as a Christmas picnic in the Botanic Gardens (December), Writers' Week breakfast (February), coffee catch-up (April), post-conference drinks (June) and joint drinks with Writers SA (July).

contemporary writing with writer Noè Harsel.

Our Zoom meetings continued to offer opportunities for interstate and regional members with three book clubs (October/March/June), an end-of-year Zoom trivia night (December) and grammar refresher (August). Thanks to Alice Healy Ingram and Kirsty Smeaton for their joint efforts as events officers and to the entire committee for a robust and varied events program.

The committee held a strategic planning day shortly after the ABM to focus our vision and our energy on areas where we thought we could most achieve impact and benefit for our members. The three areas we focused on were: long-term vision and planning; IPEd-wide alignment; and

member engagement. Much work happened behind the scenes in laying the foundations for the pathways we are still working towards, and we recognise that what these three streams look like will also change over time. The committee embraced these areas for development and they continue to be a focus at each meeting.

Our membership has remained constant with 106 active financial members at the end of June 2021, compared with 108 at the same time last year. This includes 11 new members since our 2020 ABM. Membership officer Adele Anderson AE contacts new members to extend our welcome and outline some of the benefits of their new membership.

It will be no surprise that our 2020–21 budget did not align with our original budget predictions. EdSA did not renew its membership with networking space Intersect, which has meant fewer expenses and, on the other hand, less income from

events that would have normally been held. Like other branches, we will continue to focus on Zoom professional development and meetings, and we have been so pleased at the broader reach these events have had and the increased opportunities for more remote members to be more active. Our 2021–22 budget, prepared by budget officer Adele Anderson AE with input from the committee, aims to be much more agile to cope with changing circumstances.

We were very pleased to welcome three new accredited editors from our state in 2020, and congratulate them on their efforts in passing the accreditation exam. EdSA continues to be represented on the IPEd Accreditation Board by branch committee member Jo Vabolis AE. Jo has fulfilled this role very capably for almost four years and has recently been nominated for a further two-year term. Jo also co-presented at the 2021 IPEd conference on the Evolution of IPEd's Accreditation Scheme.

This year, Editors Tasmania (EdTas) has welcomed two new members, increasing our numbers to 34: two Honorary Life Members, 30 professional members, eight associates and one student.

Our main activity for this year was, of course, the IPEd conference. Nevertheless, we had a small number of social and professional events, including a pre-Christmas lunch at Ross. Our planned copy editing workshop had to be cancelled due to COVID-19 restrictions, but a Zoom seminar on editing family history was a great hit, with more than 90 registrations.

We had positive responses to our attendance at the Tasmanian Indie Book Fair, which offered an opportunity to educate authors and other members of the public on the work of editors.

After the exam, we were able to welcome two new Accredited Editors to our ranks: Melita Eagling AE and Dr Eve White AE.

At the first post-AGM committee meeting, Elizabeth Spiegel AE was reappointed as President and Liz Charpleix AE as Budget Officer. The work of the Secretary was re-distributed between Alex Sutherland, Susan Scott and Sabine Borgis. Sue Scott resigned from the committee in January this year.

As our Accreditation Board delegate, Vicki Nelson AE was an ex-officio member of the committee; in November she was joined by our new IPEd Director Gordon Campbell AE. Vicki resigned from the AB after the exam, and we have so far been unable to find a replacement.

Despite the easing of restrictions, we continued to meet monthly via Zoom.

As President, I'd like to thank everyone who has been on the committee for their work.

COVID-19 threw our plans into disarray. Initially, we hoped we would be able to go ahead — that by now it would all be over. Then we considered the possibility of a hybrid conference, with some speakers and delegates attending in person, while others attended via Zoom.

Upon investigating, however, we established that a hybrid conference would be unfeasibly expensive. So instead, we delivered a virtual conference. Not everything ran smoothly, and we didn't manage to deliver much in the way of networking opportunities. However, while we have yet to analyse all the feedback received, it is fair to say that the conference was a success: both delegates and organisers learned a great deal.

We continue to run events on a break-even basis — those that make a small profit are balanced by those that run at a small loss. Committee members are reimbursed for expenses incurred on behalf of the branch, but not otherwise paid.

Allowing a little quibbling around definitions, 2020 was Editors Victoria's (EdVic) 50th anniversary. In the grip of a COVID-19 lockdown, the committee resigned itself to scaling down celebrations and taking them online.

And then, with typical energy and enthusiasm, the plans took off again. That special event in December 2020 encapsulated the best of the branch: its rich history; a membership of diverse talents; committed work both on screen and behind the scenes; an ambitious vision; and a spirit of humour, creativity and teamwork.

Through 2020–21's succession of lockdowns, the EdVic team was committed to maintaining its program to connect and support members. We became increasingly practised at using Zoom to run PD workshops and speaker meetings, while heading online for 'Zoom cuppas' and staying in touch on social media and through *Gatherings*. Membership numbers grew throughout this period.

In particular, Communications Officer Bridget Blair coordinated substantial newsletter contributions every month, Events Officer Marie Pietersz organised nine online speaker meetings with an average audience of almost 60, and Professional Development Officer Claire Kelly AE oversaw seven PD workshops (most sold out, some repeated, and two subsequently presented by other branches) with a total of 195 attendees. Zoom allowed us to widen our audience, lower prices, invite international speakers, record select

meetings and use live captioning to improve accessibility. Given the popularity of these activities, we could safely cover costs and returned a surplus of more than \$13,000. To further help members access PD, we introduced student and concession discounts for our workshops and meetings, and subsidised 24 members to attend the IPEd conference. (The subsidies totalled \$1440, drawn from branch reserved funds.)

We've now begun cautiously reintroducing in-person activities
— lunches in Melbourne and
Castlemaine, pre-conference drinks in Melbourne. This meant creating a detailed COVIDSafe Plan and branch COVID-19 protocols. These will stand us in good stead for some inperson PD workshops and speaker meetings in future.

The past year's work was ably supported by the other executive officers (Jane Fitzpatrick AE, Vice-President; Margaret Trudgeon, Secretary; Marnie Hannagan, Budget; Susan Pierotti, Freelance Affairs), subcommittee members (Imogen Bannister, Dalida Boustead, Naomi Johnson, Karina Smith), Student Adviser Cassandra Wright-Dole,

Mentoring Liaison Maryna Mews, new Victorian IPEd Board member Lan Wang and outgoing Board member Dr Reneé Otmar DE, Branch Admin Officer Donna Quinn, admin support Liz Atkinson and freelance proofreader Cassandra Ball.

The committee has remained substantially unchanged for its new term, but Cassandra has become our Accessibility Adviser, and we have retired the Freelance Affairs role, though Susan remains our Accreditation Board Delegate. We welcome Student Adviser Tim Loveday and subcommittee member Jenn Zabinskas. We hope to recruit a Project and Outreach Officer and additional subcommittee volunteers.

Our recent survey of 145 branch members will help the committee plan for the year ahead. We have also been inspired and galvanised by the recent conference. In the coming year, we hope to strengthen accessibility and inclusion; improve outreach to students, new editors and in-house editors; and run some engaging in-person activities to complement further Zoom offerings.


